Project Background

Historically, West Bengal has played an important role for the development of the textile and apparel industry and till date it is a major manufacturer of hosiery products, garments and technical textiles. West Bengal has the right combination of the factors required for the growth of the sector. The RMG industry not only propels the growth of spinning, weaving, dyeing and finishing industries, production of accessories and spare parts, but also renders large externalities by contributing to other economic activities in such areas as banking, insurance, real estate, packaging, hotels and tourism, recycling, consumer goods utility services and transportation. RMG sector has overwhelmingly high backward linkage with textile sector providing fabrics, yarn and other ancillaries. It has important backward linkage with utilities such as electricity, gas, and machinery and spare parts supplying.

16 National Highways are connecting the State with rest of the India and two upcoming Asian highways will connect the State with Nepal, Bhutan and Bangladesh. Upcoming Amritsar Kolkata Industrial Corridor is expected to boost industrial linkages of West Bengal with 20 cities across seven states in India. Two large container and bulk handling river ports exist at Kolkata and Haldia. One deep seaport is coming up at Tajpur. The State has two international airports at Kolkata and Bagdogra. Apart from this the domestic airport in Durgapur caters to major metros in India.

Government of West Bengal has identified following areas as strategic thrust areas for attracting new investment in textile and apparel sector in next three to five years:

- ✓ Scaling up readymade garment sector
- ✓ Diversifying into technical textiles
- ✓ Development of complete value chain for man-made fiber-based textiles and apparel
- ✓ Strengthening and upgrading weaving, knitting and hosiery industry
- ✓ Developing the support ecosystem textile auxiliaries and machinery
- ✓ Setting up of a designing and technology facilitation center
- ✓ Promotion of cleaner production system

Policy Support:

- ✓ MSME Department has launched **West Bengal Textile Incentive Scheme (WBTIS), 2022**, with the objective of extending fiscal incentives to textile sector industries across the entire value chain starting from fibre to stitched garments, to set up and expand such units in the state. An eligible textile Industry in the state will be entitled to state capital investment subsidy for its approved project which will vary from a maximum of Rs 20 crore to 50 crore and there will be a 100 per cent waiver of electricity duty for 5 years from the date of commencement of production subject to a maximum of Rs 100 lakh per year.
- ✓ The industry can also benefit under PLI scheme as per GoI guidelines.
- ✓ Government of West Bengal has taken major policy reforms for the Ease of Doing Business (EoDB) which includes automation of the approval processes, digitization of the processes, increasing the tenure of validity of approvals, simplification of the processes, single window clearance system, 'No Bandh' regime, time bound service delivery etc.
- ✓ The State govt. is encouraging setting up of Industrial Parks under the SAIP Scheme by providing fiscal and non-fiscal incentives on minimum 5 acre land
- ✓ The Banglashree Scheme offers different incentives to MSME units.

Advantage Bengal: In Textiles and Apparels:

- ✓ Govt. focus and favourable policies to support the industry. Exclusive Incentive Policy on Textiles providing fiscal incentives on various items to all the textile units operating in the State
- ✓ Most of the inputs used in textile manufacturing are readily available here.

- ✓ Bengal enjoys a comparative advantage in terms of skilled manpower and in cost of production relative to major textile producers. The TVET institutions and training centers provide skilled manpower for the shopfloor level.
- ✓ Industrial Infrastructure: A number of textile parks, including fabric manufacturing parks are functional / under implementation. Government is setting up integrated Textile Parks in Ashoknagar, Kalyani, and Raiganj. Largest Hosiery Park in the country is coming up on 125 acre land at Howrah. Apparel Wholesale Hub at Nungi is being developed in PPP mode on nearly 9 acre land
- ✓ Largest RMG cluster in Metiaburuz involving 5,00,000 artisans .
- ✓ Abundance of water and provision of marine discharge facilities for processing plants

Factors favourable for growth of textiles/apparels in West Bengal:

- ✓ Growing population is a key driver of textile consumption in the country.
- ✓ Capacity building led to low cost of production per unit in the apparel industry
- ✓ Rising incomes has been a key determinant of domestic demand for the sector with incomes rising in the rural economy as well as the upward push on demand from income side is set to continue.
- ✓ This sector also witnessed increased outsourcing over the years as players moved up the value chain .

The MSME and Textiles Dept., Government of West Bengal has set up an Apparel Buying Hub (ABH) at Paridhan Garment Park at Chingrighata, Kolkata which is well connected by road, rail, and air. 2 buying houses are presently operational there and the rest of the space to be allotted amongst interested buying houses to set up office spaces/sourcing outlets.

Objective of ABH: To encourage new entrepreneurs in garment business.

A lot of small garment factories are being set up, which have no specified buyer. The Buying house would handhold the small manufacturers/traders and provide them sound opportunity by giving garments order as well as ensure that they have the capability to complete the order according to buyers demand/specifications. As a result of this new entrepreneurs will be willing to come forward to invest in garments sector by setting up more garments factories.
